# UTWSD Celebrates Permit Victory and 5 Year Anniversary!

December 18<sup>th</sup>, 2014 marked the five year anniversary of the taxi driver strike of 2009. Since then UTWSD has been the *only* organization consistently fighting for driver's rights and a better San Diego taxi industry. But we could not have done it alone.

We invited drivers, friends and allies to join us so we could say thank you for making all of this possible. The driver strike was a momentous event for drivers but if it wasn't for the hard work throughout the five years, educating the public and our elected officials, building alliances, mobilizing our community to vote and so much more we would not be where we are today.

The victory party was held at United Domestic Workers (UDW) Hall where hundreds of drivers and supporters came out to enjoy food by our sponsors UDW and Fatuma Restaurant and honor our special guests.

UTWSD Lifetime members, the drivers who sat on the floor of our office with no furniture back in 2010 and who are still organizing today accepted awards with Liibaan Ahmed giving a speech on their behalf. Next we honored emerging leaders. These are drivers who have helped us organize in the past few years and even months leading up to our big win at Golden Hall. These drivers are rising star organizers who believe in the cause and

are dedicated to building UTWSD.

We also honored all our elected officials who have not only voted for our recent policy reform to lift the cap but also have stood by UTWSD throughout the years including Councilmember David Alvarez and our City Attorney Jan Goldsmith. Our friend Assemblywomen Lorena Gonzalez spoke about her history with UTWSD going back to when she was head of the Labor Council and how she always believed in our cause!

Our champion Marti Emerald was not able to attend because of her last treatment of chemotherapy but, her Senior Council Representative Ralph Dimarucut who was instrumental in helping pass the lift the cap reform received the award on her behalf while also presenting UTWSD with a city proclamation naming December 18<sup>th</sup>, 2014 UTWSD Day in the City of San Diego!

Lastly we were able to honor all the organizations, researchers and labor leaders who have been key to our campaign for a better, more equitable taxi industry.

Emerald, a champion of taxi
drivers and the community.

To say that Councilmember Marti Emerald has been a champion for taxi drivers is an understatement though. Since becoming Chair of the Taxi Advisory Committee in 2011 Marti has been and standing beside UTWSD for a better, safer and more equitable taxi industry.

Councilmember Emerald was there for our peaceful protest to call attention to violence against taxi drivers and has fought to get video cameras in cabs to protect drivers lives.

She led the way for equalizing the Taxi Advisory Committee and first ever historic taxi driver elections, giving lease drivers a voice on an influential MTS board.

Councilmember Emerald fought alongside former Mayor Bob Filner to reform the taxi industry, including ending a long term contract with MTS to regulate the taxi industry.

The City is still contracting with MTS but, the contract includes a cancellation clause that could allow the City to take over if they want to.

And Marti did not stop there. Even after new power shifted at City Hall that temporarily ended the possibility of the City cancelling its contract with MTS, she took our taxi issues to the Public Safety Committee to make sure that taxi industry reform was addressed.

Councilmember Emerald has done this and so, so much more for not only taxi drivers but all of San Diego. Recently she has been doing all this while also bravely battling cancer.

Thank you Marti, for being a true advocate. We are eternally grateful and look forward to many, many more years fighting alongside you.
